1. To pay, prior to becoming delinquent, all taxes, assessments, dues and charges of every kind imposed or levied upon the real property described below; and



Without the prior written consent of The Association, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein; and

3. Herby assign, transfer and set over to The Association, its successors and assigns, all monies now due and hereafter becoming due to the undersigned, as rental, or otherwise, and however for or account of the certain real property situated in the

County of Greenville, State of South Carolina, described as follows:
 All that piece, parcel, or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying, and being in the state of South Carolina, County of Greenville, in Grove Township, containing seven-tenths (7/10) acres, more or less, having the following metes and bounds, to-wit:
 Beginning at an iron pin on corner of lot formerly owned by S. L. Goldsmith lot on Eastside of Highway 20 (formerly 29); thence along line of S. L. Goldsmith S. 83 E. 6 chains 20 links to center of P and N Railway; thence along center of P and N Railway N. 4 E 1.20 chains to an iron pin; thence N 28 1/2 W. 6.24 chains to a point in Highway 20 (formerly 29); thence S. 10 1/2 E. to an angle in old road bed 20 links; thence S. 4 W. 1.00 along highway to beginning corner.

4. That if default be made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to The Association when due, The Association, at its election, may declare the entire remaining unpaid principal and interest of any obligation or indebtedness then remaining unpaid to The Association to be due and payable forthwith.

5. That The Association may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as The Association, in its discretion, may elect.

6. Upon payment of all indebtedness of the undersigned to The Association this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benefit of The Association and its successors and assigns. The affidavit of any officer or department or branch manager of The Association showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
