
DOLLARS (\$ 12,500.00 ), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land situate, lying and being on the Southern side of Pinedale Drive, near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 9 as shown on plat prepared by R. K. Campbell, dated May, 1950, revised July 9, 1959, entitled "Property Plat, P. L. Bruce", recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book XX at page 123, and having, according to said plat, the following notes and bounds:

BEGINNING at an iron pin on the Southern side of Pinedale Drive at the joint great corner of Lots Nos. 8 and 9, and running thence with the line of Lot No. 8 S. 19° 27' E. 108.8 feet to an iron pin in the subdivision property line; thence with the said subdivision property line S. 63° 10' W. 69.5 feet to an iron pin at the joint rear corner of Lots Nos. 9 and 10; thence with the line of Lot No. 10 N. 19° 27' E. 116.7 feet to an iron pin on the Southern side of Pinedale Drive; thence with the Southern side of Pinedale Drive N. 70° 33' E. 60 feet to the point of beginning.
