TO ALL WHOM THESE PRESENTS MAY CONCERN: William A. Scogin and Marcelle M. Scogin

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Six Thousand and No/100-----

BEGINNING at an iron pin on the northern side of Olde Orchard Lane at the joint front corner of Lots 169 and 170 and running thence with the joint line of said Lots, N. 05-27 W. 143.17 feet to an iron pin on the line of Lot 166; thence with the line of Lot 166, N. 86-57 E. 32.45 feet to an iron pin at the corner of Lot 167; thence with the line of Lot 167, S. 77-46 E. 33.75 feet to an iron pin at the corner of Lot 168; thence with the line of Lot 168, S. 77-46 E. 119.87 feet to an iron pin on the northern side of Olde Orchard Lane at the joint front corner of Lots 168 and 169; thence with the northern side of Olde Orchard Lane, S. 77-46 E. 119.87 feet to the point of beginning.
