TO ALL WHOM THESE PRESENTS MAY CONCERN:

John C. Fowler and Suzanne H. Fowler

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C. (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Fifty-five Thousand and no/100

DOLLARS (\$ 55,000.00

) with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situated, lying and being in the County of Greenville, City of Greenville, State of South Carolina, lying at the northeastern intersection of McDaniel Avenue and Larneau Drive, being shown and designated as lot no. 2 on plat of the Estate of John T. Jenkins, prepared by Dalton & Neves, dated July, 1932, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book No. 78 Page 373, and having, according to said plat, the following metes and bounds, to-wit:

3- BEGINNING at a point on the eastern side of McDaniel Avenue, the joint front corner of lots 1 and 2 and running thence along the eastern side of McDaniel Avenue S. 9-21 W. 75 feet to a point at the northeast corner of McDaniel Avenue and Larneau Drive; thence, along the northern side of Larneau Drive, S. 68-16 E. 175 feet to a point at the joint corner of lots 2 and 3; thence, along the joint line of said lots N. 21-44 E. 82 feet to a point at the joint rear corner of lots 1 and 2; thence, with the joint line of said lots, N. 19-11 E. 191.14 feet to the joint front corner of lots 1 and 2 on the eastern side of McDaniel Avenue, the point and place of beginning.
