

account by the Mortgagor, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor is hereby specifically  
paid by the Mortgagor or and before the sealing and delivery of this instrument, the receipt whereof is hereby acknowledged, has given  
and bargained, sold and released, and by these presents done grant, bargain, sell and release unto the Mortgagor, its successors and as  
signs:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situated, lying and  
being in the State of South Carolina, County of Greenville, on the Southeast side of  
West Augusta Place Street, being shown as Lot #32 on a plat of  
property of D. W. Cochran Estate and Minnie P. Cochran, made  
by Dalton & Neves Engineers, dated July, 1937 and recorded in  
the RMC Office for Greenville County in Plat Book I at Page  
92 and Page 93, and having, according to said plat, the follow-  
ing metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeast side of West Augusta  
Place Street, at the joint front corner of Lots 32 and 33 and  
running thence along the line of Lot 33, S. 52-04 E., 234.8
