THIS MORTGAGE, made this 15th day of August

receipts to the Mortgagee; and in case of failure of the Mortgagor so to do, the Mortgagee may do so and add the cost thereof  
to the amount of the Mortgage Debt so as to become so much additional indebtedness secured by this Mortgage; and the ex-  
ercise of such option shall not be deemed a waiver of the breach of any covenant or agreement herein contained.

3. To pay the Mortgage Debt and interest thereon according to the terms and conditions of the Note and any amendment,  
and to pay all taxes, assessments, public and other charges or demands thereon and as now when due, all ground rents, taxes, water rents, assessments, public and
