(2) all future advances that may subsequently be made to Borrower by Lender, to be evidenced by promissory notes, and all renewals  
and extensions thereof, and (3) all other indebtedness of Borrower to Lender, now due or to become due or hereafter contracted, the

ALL that piece, parcel or lot of land situated in the County of Greenville, State of S.C.,  
South Carolina, Grove Township, and located on the west side of S.C. Highway No. 50,  
and having the following rates and bounds, to-wit:  
BEGINNING at an iron pin in S.C. Highway No. 50, and thence S. 63-15 W. 943 feet to an  
iron pin; thence N. 66-24 W. 246 feet to an iron pin; thence S. 35-42 W. 298.7 feet to  
an iron pin; thence N. 55-45 W. 313 feet to a point; thence N. 63-15 E. 1,580 feet to  
an iron pin in S.C. Highway No. 50; thence S. 22-20 E. 100 feet to a point in said road,
