All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot 133, Section 2 on Plat of Oak-Crest, which plat is recorded in the RMC Office for Greenville County, South Carolina, in Plat Book CG, pages 130 and 131, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeasterly side of Brownwood Drive, joint front corner Lots 139 and 135; and running thence along Brownwood Drive N. 60-43 W. 70 feet to an iron pin; thence N. 29-12 E. 150 feet to an iron pin; thence S. 60-48 E. 70 feet to an iron pin, joint rear corner Lots 139 and 133; thence S. 29-12 W. 150 feet to an iron pin, the point of beginning.
