- (1) Mortgage—This document, which is dated January 14, 1983, is S.C. will be called the "Mortgage".  
(2) Mortgagor—Patricia L. Hancock will sometimes be called "Mortgagor" and sometimes simply "I", "Me", "my", "mine", "myself", and "us" refers to the Mortgagor.  
(3) Lender—The South Carolina National Bank will be called "Lender" and sometimes simply "you", "your" and "yours" refer to Lender. Lender is a national banking association which was formed and which exists under the laws of the United States of America.

Lender's address is P. O. Box 969, Greenville, S. C. 29602  
Note—A promissory note is signed by William J. Bullock and dated January 13, 1983 will be called the "Note". The Note shows that I have promised to pay Lender
