

ALL that piece, parcel or lot of land, with improvements thereon, situate, lying and being on the eastern side of Avon Drive near the City of Greenville, in the County of Greenville, State of South Carolina and known and designated as Lot No. 23 on plat of Avon Park Subdivision recorded in the R.H.C. Office for Greenville County in Plat Book KK at Page 71 and having, the following metes and bounds, to-wit:
