THIS MORTGAGE is made this 14th day of January 1981 between the Mortgagor, Orion T. Rhodes and Mary T. Rhodes (herein "Borrower"), and the Mortgagee, Carolina Federal Savings and Loan Association, a corporation organized and existing under the laws of the state of South Carolina, whose address is Post Office Box 10148, Greenville, South Carolina (herein "Lender").
