the Mortgagor(s), SEND GREETING:

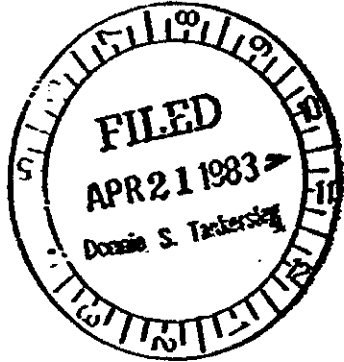
WHEREAS, the said Mortgagor(s) in and by our certain promissory note in writing, of even date with
