MORTGAGE

THIS MORTGAGE is made this 30th day of April, 1981, between the Mortgagor, E. R. Venesky, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

This being the same property conveyed to the mortgagor by deed of Vencil S. and Pauline B. Jelovchan and recorded in the RMC office for Greenville County on May 7, 1980 in deed book 1125 at page 292.
