THIS MORTGAGE is made this 7 day of June 1982 between the Mortgagor, William O. Powell, Jr. and Catherine A. Powell (herein "Borrower"), and the Mortgagee, AMERICAN FEDERAL SAVINGS AND LOAN ASSOCIATION, a corporation organized and existing under the laws of SOUTH CAROLINA, whose address is 101 EAST WASHINGTON STREET, GREENVILLE, SOUTH CAROLINA (herein "Lender").

ALL that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, being shown and designated as Lot Number 25 of the Buxton Subdivision, as recorded on plat in Plat Book 4-N at Pages 2, 3 and 4 of the RMC Office for Greenville County.

This is the same property conveyed to the Grantors by deed of W.N. Leslie, Inc. recorded January 27, 1977 in Deed Book 1050 at Page 157 of the RMC Office for Greenville County.

This property is conveyed subject to all easements, restrictions, zoning ordinances and rights-of-way of record, or on the ground, which may effect said property.
