KNOW ALL MEN BY THESE PRESENTS, Dated January 20, 1967

WHEREAS, the undersigned Walter L. Williams (same as Willie Lee Williams) and Mary Lee Williams

residing in Greenville County, South Carolina, whose post office address is Route One (1), Greenville, South Carolina 29611, herein called "Borrower," are (is) justly indebted to the United States of America, acting through the Farmers Home Administration, United States Department of Agriculture, herein called the "Government," as evidenced by a certain promissory note, herein called "the note," dated August 4th, 1966, for the principal sum of Twelve thousand and 00/100 Dollars (\$12,000.00), with interest at the rate of five percent (5%) per annum, executed by Borrower and payable to the order of the Government in installments as specified therein, the final installment being due on August 4, 1999 which note authorizes acceleration of the entire indebtedness at the option of the Government upon any default by Borrower; and
