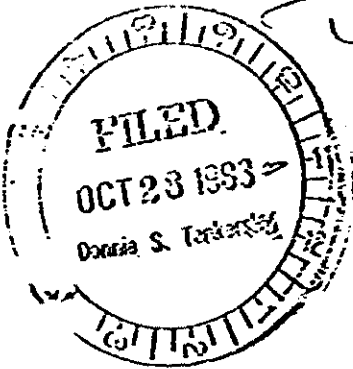
BEGINNING at an iron pin on the southwestern side of Hale Drive, joint front corner
