THIS MORTGAGE is made this 20th day of December, 1974,  
between the Mortgagor, Ricky A. Setzer and Sue Lynn Setzer (herein "Borrower"),

for Greenville County in Plat Book 4-R at Pages 36 and 37.

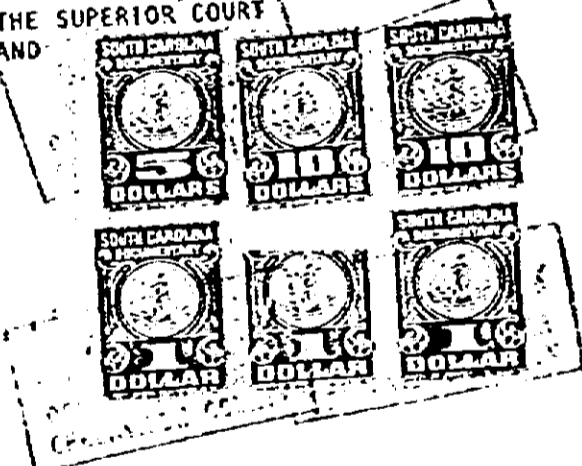
