ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, lying and being in the State of South Carolina, County of Greenville, and being all of Lot No. 7 and the major portion of Lot No. 7 on plat of Welcome View Subdivision made by Piedmont Engineering Service, August 1948, and recorded in plat-book U page 155 and having according to said plat the following metes and bounds, courses and distances to-wit:
