and the final payment being due June 6, 1988,

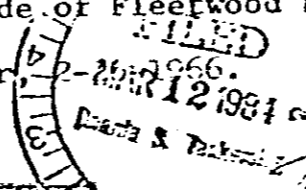
with interest thereon from date of the rate of 18.00 per centum per annum, to be paid:

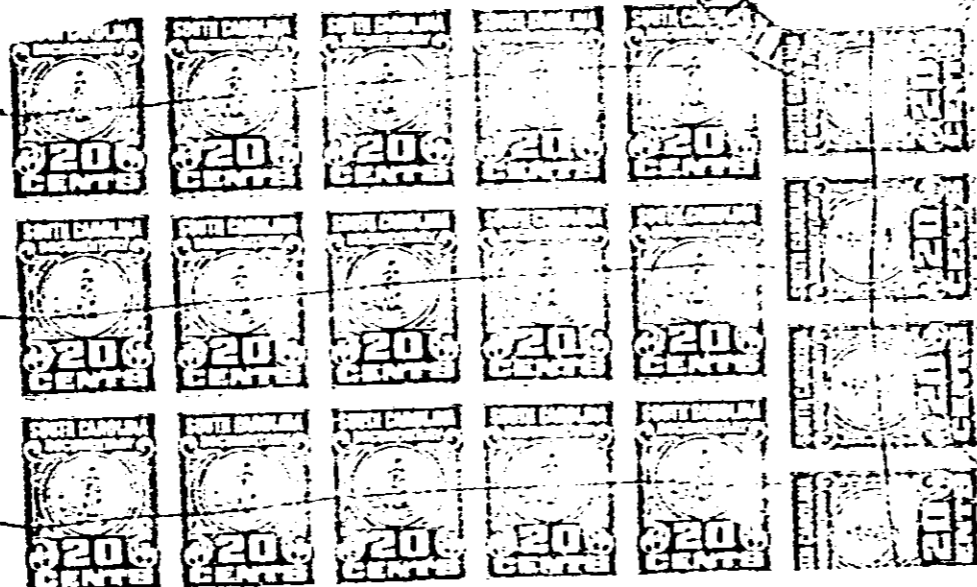
