All that piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 110 on Map of Piedmont Heights, plat of which is recorded in the RMC Office for Greenville County, South Carolina, in Plat Book M, at page 123, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the northeasterly side of Ivydale Drive (formerly Churchill Avenue) joint front corner Lots 108 and 110, said iron pin being 420 feet in a westerly direction from the intersection of Ivydale Drive and Omar Avenue; and running thence N. 24-0 E. 175 feet to an iron pin; thence S. 66-0 E. 60 feet to an iron pin; thence S. 24-0 W. 175 feet to an iron pin on Ivydale Drive, joint front corner Lots 109 and 110; thence along Ivydale Drive N. 66-0 W. 60 feet to an iron pin, the point of beginning. 29306
