"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 14 of Cane Creek Subdivision, containing 0.43 acres, more or less, and being further described as follows:

BEGINNING at an iron pin on the northeastern side of Berry Road in the middle of a Duke Power right-of-way and running thence N 73-33 E, 100 feet to an iron pin; thence N 39-42 E, 121.4 feet to an old axle; thence S 18-53 E, 102.3 feet to an iron pin; thence S 33-07 W, 149.62 feet to an iron pin on the northeastern side of Berry Road; thence with Berry Road N 51-12 W, 160.2 feet to an iron pin in the center of said right-of-way.
