This Mortgage, made this 16th day of July 1982 by and between Lawrence E. Woodard and Jean Woodard,
hereinafter referred to as Mortgagors, and Dial Finance Company of South Carolina, herein after referred to as Mortgagor, witnesseth

Whereas, Mortgagors are indebted on their promissory note of even date in the sum of \$ 4042.85, payable to Mortgagor and evidencing a loan made to Mortgagors by Mortgagor, which said note is payable in monthly installments, and according to the terms thereof payment in advance may be made in any amount at any time, and default in making any monthly payment shall, at the option of the holder of said note, and without notice or demand unless required by law, render the entire sum remaining unpaid on said note at once due and payable.

NOW KNOW ALL MEN, that in consideration of said loan and also in consideration of three dollars (\$3) to the Mortgagors in hand well and truly paid by Mortgagor at and before the sealing and delivery of these presents, receipt whereof is hereby acknowledged, the Mortgagors hereby grant, bargain, sell and release unto the Mortgagor, its successors and assigns, the following described real estate, situated in the County of Greenville and State of South Carolina, to-wit:

ALL that piece, parcel or lot of land, together with buildings and improvements, situate, lying and being on the Southeastern side of Bagwell Avenue in Greenville County, South Carolina, being shown as the front portion of Lot No. 5 of the Property of W. T. Looper on a Plat recorded in the RNC Office for Greenville County, South Carolina in Flat Book BB, Page 6, and being further shown on a more recent Plat of the Property of Charles Wilber Nichols and Teresa B. Nichols made by Jones Engineering Services dated May 1972, and recorded in the RNC Office for said County and State in Plat Book 42, Page 99, reference to which is hereby craved for the metes and bounds thereof.

Title received from Lillie C. Cooper by deed dated 10-3-80 & recorded 10-6-80 in vol. 1134 pg. 942.

To have and to hold, with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, unto said Mortgagor, provided always, and this instrument is made, executed, sealed and delivered upon the express condition that if the said Mortgagors shall pay in full to the said Mortgagor the above-described Note according to the terms thereof, and all other sums secured hereby, then this Mortgage shall cease, determine and be void, otherwise it shall remain in full force and virtue. Upon default in making any payment of said Note when the payment becomes due, then the entire sum remaining unpaid on said Note shall be due and payable by the exercise of the option of acceleration above described, and this Mortgage may be foreclosed as provided by law for the purpose of satisfying and paying the entire indebtedness secured hereby.

This mortgage is given to secure the payment of the above-described note, as well as all other sums and future advances which may hereafter be owing to Mortgagor by Mortgagor however evidenced. It is understood and agreed that the Mortgage may from time to time make loans and advances to Mortgagors, all of which will be secured by this mortgage, provided however that the total amount of existing indebtedness and future advances outstanding at any one time may not exceed the maximum principal amount of \$75,000, plus interest thereon, attorneys' fees, and court costs.

The Mortgagors covenant that they exclusively possess and own said property free and clear of all encumbrances except as otherwise noted, and will warrant and defend the same against all persons except the Mortgagor. Any failure of the Mortgagor to enforce any of its rights or remedies hereunder shall not be a waiver of its rights to do so thereafter. Whenever the context so requires, plural words shall be construed in the singular.
