THIS MORTGAGE is made this 10th day of July 1981, between the Mortgagor, Richard K. Toomey and Mary Lorraine Graef (herein "Borrower"), and the Mortgagee, AMERICAN FEDERAL SAVINGS AND LOAN ASSOCIATION, a corporation organized and existing under the laws of SOUTH CAROLINA, whose address is 101 EAST WASHINGTON STREET, GREENVILLE, SOUTH CAROLINA (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Fifty-Five Thousand and no/100 Dollars, which indebtedness is evidenced by Borrower's note dated July 10, 1981 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on July 1, 2011

Lot No. 22; thence with the line of Lot No. 22 S. 84-16 W. 180.1 feet to an iron pin in the line of pin on the eastern side of Selwyn Drive; thence with the eastern side of Selwyn Drive N. 5-44 W. 90 feet to the point of beginning.

This is the identical property conveyed to the Mortgagors herein by deed of Russell B. Westmoreland and Kristin Westmoreland, dated July 6, 1981, and recorded in the RMC Office for Greenville County, South Carolina, in Deed Book 1157, at page 517, on July 10, 1981.

In addition to and together with the monthly payments of principal and interest under the terms of the Note secured hereby, the mortgagor promises to pay to the mortgagee a monthly premium necessary to carry private mortgage guaranty insurance until the principal balance reaches 80 percent of the original sales price or appraisal, whichever is less. The estimated monthly premium for the first nine years will be .02 percent of the original amount of the loan. The estimated monthly premium for each year thereafter will be .01 percent of the original principal balance of this loan. The mortgagee may advance this premium and collect it as part of the debt secured by the mortgage if the mortgagor fails to pay it.
