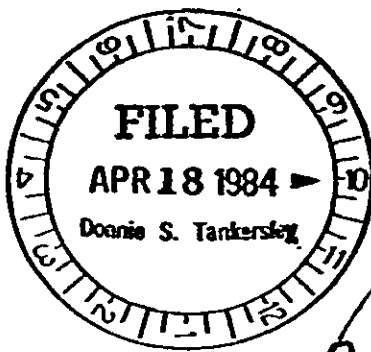
with interest thereon from date at the rate of Eight (8%) per centum per annum, to be paid: monthly

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot No. 80, on Plat of Heritage Hills Subdivision, which plat is recorded in the REC Office for Greenville County, South Carolina, in Plat Book YY, Page 187, and having, according to said plat, the following metes bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Richbourg Road, joint front corner Lots 80 and 103, and running thence with Richbourg Road, N. 16-12 W. 93 feet to an iron pin at the southeastern corner of the intersection of Richbourg Road and Butler Springs Road; thence with the curve of the intersection of said roads, the chord of which is N. 32-01 E. 33.3 feet to an iron pin on the south side of Butler Springs Road; thence with the south side of Butler Springs Road, N. 80-15 E. 148 feet to an iron pin; thence with the line of Lots 80 and 81, S. 15-39 E. 98.3 feet to an iron pin; thence with the line of Lots 80 and 103, S. 73-41 W. 171 feet to an iron pin, the point of beginning.
