THIS MORTGAGE made this 27th day of August, 19 83  
among Robert D. Sampson and Irma W. Sampson (hereinafter referred to as Mortgagor) and FIRST UNION MORTGAGE CORPORATION, a North Carolina corporation (hereinafter referred to as Mortgagee):
