MORTGAGE

THIS MORTGAGE is made this 16th day of December, 1983, between the Mortgagor, W. Eugene Estes and Leila P. Estes, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Six Thousand Eight and no cents Dollars, which indebtedness is evidenced by Borrower's note dated December 30, 1984, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on December 30, 1984.

TO SECURE in Lender (a) the repayment of the indebtedness evidenced by the Note, with interest at the rate of 12% per annum, (b) the joint line of said lots, N. 30-03 W. 180 feet to an iron pin, joint rear corner of Lots 9 and 10; thence with the joint line of said lots, N. 51-15 E. 250 feet to an iron pin on the west side of Seabrook Court; thence with the line of said street, S. 30-22 E. 125 feet to an iron pin; thence along a curving course (the chord of which is S. 12-08 W.) 37 feet to an iron pin on the north side of Fontaine Road; thence with the line of said street, S. 54-38 W. 104.5 feet to an iron pin; thence continuing with the line of said street along a curving course (the chord of which is S. 35-38 W.) 135 feet to an iron pin, the point of beginning.

This is the same property deed to the mortgagors by deed of Elizabeth L. Marchant, dated July 14, 1964 recorded July 17, 1964 in Deed Book 753 at Page 257.

This is a second mortgage and is junior in lien to that mortgage given to First Federal Savings and Loan Association by W. Eugene Estes and Leila P. Estes dated March 2, 1976, and recorded March 2, 1976 recorded in the R.M.C. Office for Greenville County in Vol. 1361 at Page 379.

Borrower covenants that Borrower is lawfully seized of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
