"ALL that certain piece, parcel or lot of land with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being described as follows:

ON the north side of Churchill Circle, south of the city of Greenville, South Carolina and being known and designated as Lots 5 and 6 on a plat of the property of Clyde Dorr, recorded in the R.M.C. office for Greenville County, South Carolina in Plat Book SS at Page 107. Said property having such metes and bounds, courses and distances as are shown on said plat.
